

Power Up Your Trades with DLCs Campaign

Terms & Conditions

These Terms and Conditions shall govern the **Power Up Your Trades with DLCs** ("Campaign") organised by **UOB Kay Hian (M) Sdn. Bhd.** (hereinafter referred to as "UOBKH").

1. Campaign Period

The Campaign will run from **11 August 2026 to 11 October 2026** (both dates inclusive).

UOBKH reserves the right to amend, extend, suspend or terminate the Campaign Period at its sole discretion.

2. Eligibility

- a) The Campaign is open to new and existing individual and corporate retail customers of UOBKH (collectively referred to as "Eligible Customers").
 - b) Institutional clients, UOBKH dealer representatives and staff accounts are not eligible for this Campaign.
 - c) Eligible Customers whose accounts are suspended or closed before the prize is credited shall be disqualified from the Campaign.

3. Campaign Mechanics

- a) Participation in this Campaign is automatic. No registration is required.
- b) To qualify, Eligible Customers must successfully execute at least **three (3) buy or sell trades** in eligible Daily Leverage Certificates (DLCs) issued by **Societe Generale** and listed on the **Singapore Exchange (SGX)** during the Campaign Period.

- c) Only successfully executed trades will be considered. Cancelled, rejected or failed orders shall not qualify.
- d) UOBKH shall determine the eligibility of all qualifying trades based on its official trading records.

- e) Where multiple Eligible Customers satisfy the qualifying criteria, the **first thirty (30) Eligible Customers** based on the completion time of the qualifying trades shall be entitled to receive the Campaign prize.

4. Campaign Prizes

- a) The **first thirty (30) Eligible Customers** who fulfil the Campaign requirements shall each receive a **SGD100 trading prize**.
- b) Each Eligible Customer is entitled to receive **one (1) prize only** throughout the Campaign.
- c) The trading prize shall be credited directly into the Eligible Customer's UOBKH trading account within **thirty (30) calendar days** after the finalization of the 30 winners, or such other date as determined by UOBKH.
- d) The trading prize:
- is non-transferable;
 - is not exchangeable for cash;
 - is non-withdrawable; and
 - may only be utilised for trading purposes.

5. Determination of Winners

Eligibility will be determined based on UOB Kay Hian's trading records.

In the event multiple clients complete the qualifying trades at approximately the same time, eligibility shall be determined based on the earliest qualifying trade completion timestamp recorded by UOB Kay Hian.

UOB Kay Hian's decision shall be final and binding.

6. General Conditions

UOB Kay Hian reserves the right to:

- verify the eligibility of all participants;
- disqualify any participant found to have breached these Terms & Conditions;
- reject trades suspected of market manipulation, fraud or abuse;
- amend, suspend or terminate the Campaign without prior notice where necessary.
- change one or more of these Terms and Conditions, at any time without prior notice, in such manner as UOBKH shall deem fit, including without limitation, the eligibility of any customer, product and market, the qualifying criteria and the Campaign Period.

7. Liability

UOB Kay Hian shall not be liable for:

- any losses arising from participation in the Campaign;
 - any interruption to trading systems;
 - any failure or delay caused by circumstances beyond their reasonable control.
